Our owner portal at <u>portal.ghacm.com</u> provides 24/7 access to: view your account balance, make payments online, view association related documents, and send inquiries to your association's points of contact. Our system is role and password protected and 128-bit encrypted.

All owners are strongly encouraged to go to <u>portal.ghacm.com</u> then click on "Sign Up" and to fill out the fields to request a login. Our team will verify your information, and then send you an email with your login credentials. Please visit the 'Contact Info' page to confirm/update your email address, mailing address, and phone number. You can also elect to hide or display your contact information in the online community directory and can select your general communication preferences via the portal.
